CORAL GABLES MINT WELLNESS CENTER CYCLE REWARDS LEADERBOARD PROGRAM ("PROGRAM") IS OPEN ONLY TO LEGAL RESIDENTS OF FLORIDA WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. Head to a designated CYCLE machine and follow the on-machine instruction to recycle a plastic or metal beverage container. Once the container is accepted by

the machine, a QR Code will populate on the machine screen. Scan the QR code, click on the link and follow the prompts to enter the Promotion.

You must fully complete the registration, which may include your first and last name, date of birth, zip code, daytime telephone number (including area code), and e-mail address. Carrier's standard messaging and data rates apply.

Entries will be tracked on a public-facing leaderboard, located at cycletechnology.com/coral-gables-leaderboard/ (the "Leaderboard"). Throughout the Promotion Period, the Leaderboard will display the ten (10) entrants who have submitted the most Entries during the Promotion Period. At the conclusion of the Promotion Period, the ten (10) entrants who have submitted the most Entries and who are reflected on the Leaderboard shall be deemed the winners of the Promotion.
